

# **2020 SHORT COURSE TIME TRIAL**

Sanctioned by Masters Swimming Ontario (MSO #506) and open to all swimmers 18 years of age and over.

All swimmers will be accepted. Swimmers not registered with MSO must swim as Single-Event Registrants (club code SER). SER participants must pay an additional \$6.00 to receive MSO insurance coverage.

Swimmers under the age of 26 years, must comply with Ontario's new Rowan's Law (Concussion Safety) requirements. Review the Government of Ontario's concussion awareness at <u>https://www.mastersswimmingontario.ca/rowans-law/</u>. The required "Confirmation of Review" has been added to the online Waivers.
